# Rules Review Committee Conclusion For Allegation #1

The Rules Review Committee finds that Jennifer Lancaster violated A.C.A. 7-8-302 (1)(B) and (1)(C). She did not certify the electors chosen at the State Convention.

Jennifer Lancaster also violated RPA Rules Article III Section 7.2 and 3 by her failure to perform her duties.

The Rules Review Committee finds that the August 26th meeting was improper and invalid, such that any business conducted that evening is null and void

The newly elected District Committee members who attended the 2nd District Committee Meeting as voting members should not have been credentialed to vote.

Justifications include Article III, Section 2, Membership, Article II Section 6D, The Secretary shall serve as the chief clerical officer

and the County Executive Committee. Other duties include maintaining mailing lists, sending of the County Committee

notices of meetings, agendas for meetings, and recording minutes of the official meetings;

### **FOREWORD**

On September 10, 2024, a Complaint was received, by RPA Chair Joseph Wood, regarding the actions and activities of Jennifer Lancaster, the Second Congressional District Chairman. This complaint was accepted in accordance with RPA Rules Article VII, Section 1.

The complaint sets forth four (4) pages of allegations of repeated rules violations and includes intentionally placing Arkansas's six (6) U.S. Presidential and Vice-Presidential Electors at risk.

### ALLEGATIONS AND RULES

The Complaint was divided into five (5) sections. Each Section set forth the allegations and rule(s) allegedly violated related to the section topic. The five (5) topics are

- 1. Risking State Convention Presidential Electors
- 2. Wrongful credentialing Second District Committee
- 3. Personal Attacks against Committee Members
- 4. Illegitimate meetings
- 5. Hostility and Division

The Rules Review Committee did find that some of the actions and activities by Ms. Lancaster overlapped these topics and or violated multiple rules. The evidence relied on for each topic is referenced in the pertinent section.

The evidence submitted by Ms. Lancaster, in her defense, is also referenced in the appropriate section.

Additional evidence was discovered by the Rules Review Committee during the investigation of this complaint. Evidence not submitted by complainant or Defendant but known to the Rules Review Committee:

Complaint filed by Jennifer Lancaster against RPA Chairman Joseph Wood and Secretary of State John Thurston, an elected Republican office holder, and amended to include all but one member of the State Board of Election Commissioners.

Post on social media regarding Ms. Lancaster's support for a faction related to the Saline County Republican Committee upheaval (Post on or about October 11, 2024 on Jimmie Cavin Post)

### Allegation 1. Risking Presidential Electors

Ms. Lancaster allegedly violated A.C.A. 7-8-302 (1)(B) and (1)(C). She did not timely certify the electors chosen at the State convention. She also violated RPA Rules Article III Section 7.2 and 3 by her failure to perform her duties.

Further exacerbating the situation and continuing with activities not in the interest of RPA she participated in news interviews. In the first she stated she would not sign the certification of Electors. In the second interview she stated all was fine and there were many ways to address the Electors issue.

### 1. Allegation: Risking State Convention Presidential Electors

- a. Failure to certify Arkansas US Presidential and Vice-Presidential Electors
- b. Lancaster has made public and private comments disparaging Trump (Exhibit A I and A II); Disparaged Trump at May 2024 Saline County Republican Committee (SCRC) Meeting (VIDEO Exhibit A1)
- c. Does not care if Trump is elected (May 2024 SCRC meeting and Sept. 7 District meeting video (Exhibit A-I)
- d. Lancaster attempting to stay State Convention Chair for two years. (Exhibit A I)

KATV news stories saying she would not sign the certification of Electors followed by story that there were other ways to deal with the certification (Exhibit A)

Social media and news stories by Democrat Chris Jones re possible action against the RPA regarding electors (Exhibit A III)

Evidence submitted by Ms. Lancaster Exhibits 1, 2 and 3

All the above fall under Article III, Section 7 A 2 Working against the interests of the Republican Party. The above actions are willful violations of the referenced rules and illustrate she is working against the interest of the Republican Party. She willfully refused to perform the duties of the convention chair in addition to the allegations below of her willful failure to perform duties of the Second District Chair.

### 2. Allegation: Wrongful credentialing- 2<sup>nd</sup> District Committee RULE: RPA Rules Article III Section 7 A.2

a. Credentialed non-members at state convention for the second district and those non members voted. (photos of wrist bands on non-members (Exhibit B I))

This action was a violation of Article III Section 7 2A willful violation of the RPA Rules and meets the criteria for removal.

### 3. Allegation: Personal Attacks against Committee members RULE: RPA Rules Article III Section 7 A.2

- a. Coordinated effort to remove members of the SCRC, including executive committee members and also members of the Second District Congressional Committee (Exhibit B II)
- b. Zoom call July 13, 2024 threatened to use her power as Second District Chair to shut down the SCRC (Exhibit C, D, E I, E II)
- c. After the July 2024 monthly SCRC meeting the County Chair texted Lancaster that she was a narcissist. She then showed this text to other text exchange to other officers she had helped put into office. They failed to contradict the label used by the County Chair. (Exhibit D) Lancaster believed stating she was a narcissist was a rules violation. (See also Exhibit B I through B-IV, C, D and E)

Evidence submitted by Ms. Lancaster: Lancaster Exhibits 4,10 and 11

It is the opinion of the Rules Review Committee that Jennifer Lancaster does personally attack those who do not agree with her words or actions. Personal attacks damage the ability of a committee to properly function.

4. Allegation: Illegitimate Meetings
RULE: RPA Rules Article III Section 7 A.2
Article II 5.C County Committee Meetings
Article II 7.B and 7.C Election of Officers
Article II 8 Vacancies
Article III 2.A.3 and B Membership
Article 2.9 Removal

- a. Improper meeting on August 26, 2024. The Call did not go out to all members. The Call was not sent to the committee Secretary for distribution under Article II Section 5C of RPA rules. Some members received a mailed notice that was postmarked the day after the meeting. (Exhibit F I- F III, G)
- b. At the August 26, 2024 meeting inactive and non-members were allowed to vote. An election was held to fill District Two membership when there was no vacancy. These people were credentialed for the September 7, 2024 District meeting. Executive Committee members were also added without following RPA Rules. (Exhibit H III)
- c. The two election commission members are not allowed to serve on the Executive Committee without a variance being granted, which was not sought or obtained (Article II Section 7B) (See also RRONR 1:4; 63:13)
- d. Four active members were expelled pending investigation in violation of Article II Section 9 and due process. A member's rights can only be individually suspended through formal disciplinary proceedings and prior to the determination of their guilt, only the investigative committee can suspend those rights (EXHIBIT G III)
- e. Charges for Removal were sent to the Chair of SCRC 10 minutes before the meeting.
- f. No facts or specific charges were given to those represent who voted to expel the members pending investigation (Exhibit G II, G III)
- g. The above grounds meet the criteria for removal under Article III Section 7 A.2. Lancaster was aware the special meeting was improper at the time of the meeting (Exhibit F I, F II, G-2, G III)

Evidence submitted by Ms. Lancaster: Lancaster Exhibits 6, 7,8,10, 11

These actions are violations of Article III Section 7 2A willful violation of the RPA Rules and meet the criteria for removal.

Furthermore, the August 26th and September 19th meetings were illegitimate meetings. Justifications include Article III, Section 2,

District Committee Membership, Article II Section 6D, The Secretary shall serve as the chief clerical officer of the County Committee and the County Executive Committee. Other duties include maintaining mailing lists, sending notices of meetings, agendas for meetings, and recording minutes of the official meetings; Article II Section 6A, The Chairman shall preside at all meetings of the County Committee and the County Executive Committee, shall coordinate the political activities of the county, shall assist Republican candidates in organizing, planning, and conducting their respective campaigns in the county, and shall perform other duties as assigned by the County Committee.

- 5. Allegation: Hostility and Division caused by or contributed to by Jennifer Lancaster Rule: RPA Rules Article III 7.A
- a. Lancaster has usurped the authority of the duly elected SCRC Executive Committee directing retaliatory attacks in meetings, refusing to sit down and work out differences, encouraging others not to talk to each other and instead to only talk to her, taking credit for work of others causing chaos in meeting and destabilization of the SCRC Committee. (Exhibit H II)
- b. The disruptions she instigated prevented the SCRC from conducting the business of disbursing funds to candidates (Exhibit H I, H III)
- c. Clint Lancaster (her husband and law partner) made a motion at the September 5, 2024 SCRC meeting to ratify the business conducted at the improper August 26, 2024 meeting. (Exhibit H I)
- d. Lancaster stated at the August 26, 2024 meeting that the eight new members they were attempting to add to the Executive Committee had agreed ahead of time to find the accused members guilty before the investigation committees had been appointed. (Exhibit H III)
- e. Due to her guest, Jimmie Cavin, punching John Newcomb in the face causing chaos, the motion was not acted upon at the September 5<sup>th</sup> meeting. (Exhibit H V)
- f. The above meet the criteria for removal under Article III, 7 A 2 and RRONR 23:6)

g. Lancaster's action at the Second District meeting on September 7, 2024 also violated Article III 7 A2 (Exhibit A I, A II, I)

Evidence Submitted by Ms. Lancaster: Lancaster Exhibits 5,6,7,8,9, 10 and 11 RRC Exhibit: 2

There is hostility and division directly caused by Jennifer Lancaster at the county, district, state, and national levels of the Republican Party. These actions violate Article III Section 7.2, working against the interest of the Republican Party.

### REMEDY REQUESTED

The undersigned members of the Second Congressional District Republican Committee respectfully request that Second District Chair Jennifer Lancaster be removed as Second District Chair and banned from holding any position within the Republican Party of Arkansas, including County Committee Member, for a period of time to be determined appropriate by the State Executive Committee. We further request that all retaliatory actions led by Lancaster against all district and county committee members be reversed.

The undersigned\* request these remedies and penalties for Lancaster's repeated RPA rules violations and for attempting to sabotage the 2024 US Presidential election.

### RULES REVIEW COMMITTEE RECOMMENDATION

Recommendation of the Rules Review Committee, based on the evidence submitted with the complaint and evidence submitted by Jennifer Lancaster in her defense (as referenced above) that the following actions be taken by the RPA Executive Committee.

That an additional allegation be included. That Ms. Lancaster has violated Article III Section 7.2 Willful violation of these rules or working against the interest of the Republican Party.

Any member who files or is a plaintiff in a lawsuit against the RPA that is prima facie evidence of a willful action against the Republican Party. Any member who chooses to be a party to a lawsuit against the party has publicly attacked the organization. The lawsuit filed by Ms. Lancaster is against the RPA Chair and the Republican Secretary of State. (See RRC Exhibit:1) For this action and all other actions alleged by complainants, the Rules Review Committee makes the following Recommendations to the RPA Executive Committee.

- 1. Jennifer Lancaster be banned from membership in the Republican Party of Arkansas for twenty (20) years.
- 2. Jennifer Lancaster immediately is removed from any and all positions she currently holds at the State, District and County levels and be banned from running for any office within the Republican Party of Arkansas for twenty years.
- 3. We recommend that Jennifer Lancaster be removed from membership and any offices held in all Republican affiliated organizations including, but not limited to, the Arkansas Federation of Republican Women and the Arkansas Chapter of the Republican National Lawyers Association.
- 4. If Jennifer Lancaster runs for office as a Republican, she will receive a "DO NOT RECOMMEND" rating from the Republican Party.
